- 3. Include a dated invoice or receipt from a professional installer or contractor stating the cost to modify your existing countertop with a photograph of the before and after install.

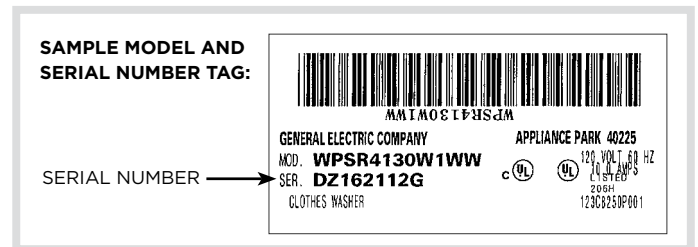
Allow 8-10 weeks to receive your prepaid Visa card.
