The P40 is that product everyone wishes he had on him to add that little extra boost to his clients' networks. Whether it be to extend the range of their WiFi or provide an internet connection to a device that requires a wired connection, the P40's favorite hobby is coming in clutch.

Our little friend here has two primary uses. Read up so you're prepared to use him in case of emergency:



Client Mode

In **Client Mode**, IP devices that rely on an Ethernet port can be connected to the network via the P40. Just plug the device directly into the P40, and the P40 will connect it to the rest of the WiFi network.

In this mode, either the 2.4 or 5GHz signal can be locked in. Locking the signal in means the device will only operate on that band.

In **Repeater Mode**, the P40 can be used to extend the wireless network to areas where a wireless signal may have been weak.

In this mode, the P40 can be connected to both the 2.4 and 5GHz networks; it will use whichever has the strongest signal.



Repeater Mode

NOTE: If you're using the P40 in client mode, repeater mode cannot be used and vice versa.
