Introduction

Thank you for purchasing the FM Direct Adapter (FMDA). The FMDA provides a superior audio connection for your Satellite Radio.

- **Static-free sound:** Virtually static-free audio connection for your Satellite Radio, hard-wired directly into your vehicle's AM/FM radio.
- **Easy switching between Satellite Radio and AM/FM Radio:** You can still hear your local AM or FM stations when your Satellite Radio is turned off.
- **Works with almost any vehicle:** Includes everything for most vehicle installations. (Additional antenna adapters may be required and are sold separately by professional installers.)

SiriusXM strongly recommends professional installation of this product in your vehicle. Ask your favorite retailer if they provide professional installation services or can recommend a professional installation service.



Note: XM Radios that are not compatible with the *PowerConnect* Vehicle Kit should be paired with the FM Direct Adapter model XMFM1.

What's in the Box?



FMDA25

Installation

The FMDA25 directly connects the FM signal from the Satellite Radio to the vehicle's AM/FM radio, reducing any interference which might be present from FM radio stations. When the Satellite Radio is turned off, the vehicle's FM antenna is automatically connected back to the vehicle's AM/FM radio. The FMDA25 connects directly in-line with the vehicle's existing AM/FM antenna input.

SiriusXM strongly recommends professional installation of this product. Many SiriusXM retailers provide professional installation services, or can recommend a professional installation service.

Considerations


Certain vehicle models will require adapters to connect the vehicle's AM/FM antenna to the FMDA25, and to connect the FMDA25 to the vehicle's AM/FM radio. These adapters are sold separately by most professional installers.

Vehicle Installation

To install the FMDA25 in the vehicle, follow these installation


instructions:

- 1 Remove the vehicle's AM/FM radio from the vehicle's dash and disconnect the vehicle's AM/FM antenna cable from the rear of the AM/FM radio.



- 2 Plug the **FM Antenna Connector (A)** from the FMDA25 into the same connector on the vehicle's AM/FM radio. (Additional antenna adapter may be required.)
- 3 Plug the vehicle's AM/FM antenna cable into the female **FM Antenna Socket (B)** of the FMDA25. (Additional antenna adapter may be required.)

- 4 Plug the **Mini Connector (C)** of the FMDA25 into the **FM** or **FM Out** connection of the Satellite Radio Vehicle Dock or Satellite Radio.
- 5 Reinstall the vehicle's AM/FM radio into the dash.




- 6 Make sure the vehicle's AM/FM radio and the Satellite Radio are turned on and tuned to the same FM channel. (Refer to the User Guide of the Satellite Radio for instructions on matching FM channels.)
- 7 Static-free audio from the Satellite Radio should be heard through the vehicle's AM/FM radio.

Secure the FMDA25

Secure the FMDA25 behind the vehicle FM radio location or

under the dash using a wire tie (not included).

Wrap the wire tie around the molded indents of the FMDA as shown to prevent the FMDA25 from slipping. Then secure it to a bracket or wiring harness using the wire tie. Avoid brackets with sharp edges and any moving parts such as gas and brake pedals.
