



Warranty Statement for Next Level Racing

What the warranty covers:

NEXT LEVEL RACING warrants its products to be free from defects in material and workmanship during the warranty period. If a product proves to be defective in material or workmanship during the warranty period, Next Level Racing will, at its sole option, repair or replace the product. The replacement unit will be covered by the balance of the time remaining on the customer's original limited warranty.

How long the warranty is effective:

Next Level Racing warranty is effective for **1 year for products purchased in used in the United States for consumer use and 90 days parts and labour warranty for commercial use**. This limited warranty begins on the date of original purchase and the purchaser must contact **NEXT LEVEL RACING** via an email to SUPPORT@NEXTLEVELRACING.COM to determine the problem and service procedures. Original date of purchase as well as proof of purchase may be requested

NEXT LEVEL RACING will either repair or replace the product at our option at no charge stipulated herein during the limited warranty period. All replaced/repaired products and parts become the property of **NEXT LEVEL RACING** and must be returned to **NEXT LEVEL RACING**. Transport to and from the closest service centre will be the responsibility of the purchaser.

What is not covered:

Any product on which the serial number has been defaced, modified or removed.

- Damage, deterioration or malfunction resulting from:
 1. Accident, misuse, neglect, fire, water, lightning, or other acts of nature, unauthorized product modification, or failure to follow instructions supplied with the product.
 2. Repair or attempted repair by anyone not authorized by **NEXT LEVEL RACING**
 3. Any damage of the product due to shipment.
 4. Causes external to the product, such as electric power fluctuations or failure.
 5. Normal wear and tear.
 6. Failure of owner to install product as per instructions in User Guide
 7. Any other cause which does not relate to a product defect.

Limitation of implied warranties:

Exclusion of damages:

NEXT LEVEL RACING'S LIABILITY IS LIMITED TO THE COST OF REPAIR OR REPLACEMENT OF THE PRODUCT & SHALL NOT BE LIABLE FOR:

1. DAMAGE TO OTHER PROPERTY CAUSED BY ANY DEFECTS IN THE PRODUCT
2. DAMAGES BASED UPON INCONVENIENCE, LOSS OF USE OF THE PRODUCT, LOSS OF TIME, LOSS OF PROFITS, LOSS OF BUSINESS OPPORTUNITY, LOSS OF GOODWILL, INTERFERENCE WITH BUSINESS RELATIONSHIPS, OR OTHER COMMERCIAL LOSS, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

4. ANY CLAIM AGAINST THE CUSTOMER BY ANY OTHER PARTY
