General Warranty Information

Warranty coverage requires a valid proof of purchase and is restricted to the original purchaser.

HyperGear reserves the right to determine the expected lifetime of its products.

For quality-related warranty claims, items will be repaired or replaced with a refurbished model of equal or similar value when available, otherwise a new item will be sent.

Limited One, Two, Three Year & Lifetime Warranty

HyperGear warrants that all products purchased from an authorized dealer will be free from qualityrelated defects in material and workmanship when the product is used for the intended purpose under normal conditions for the period stated on each product. This warranty is restricted to the original purchaser with a valid proof of purchase.

This warranty does not apply to damages incurred as a result of wear and tear from normal use over time, accidental damages, improper care, modifications, disassembly or alterations to the product, misuse and abuse, or improper operation.

For quality-related warranty claims, the product will be repaired or replaced with a refurbished model of equal or similar value when available, otherwise a new item will be sent. In no event shall HyperGear be responsible for claims beyond the replacement value of the defective product or in any way shall be liable or responsible for consequential or incidental damages.
