- Apple iPhone 12 series and 13 series
- Any Qi-enabled devices including smartphones, headphones, and smart watches

### Features

- Wirelessly charges the iPhone 12 series and 13 series (7.5W) or Android devices (10 W)
- Attaches to the back of your iPhone 12 series and 13 series using a magnetic connector
- Plugs into wall adapters, car chargers and more using an attached USB-C cable (adapter not included)
- Gives you flexible placement options with a 6 ft. (1.8 m) cable
- Sleek white housing for a clean, unobtrusive look
- Built and backed by Best Buy

**Note:** For best results, use without a case, with a thin case or with a case that has a magnetic MagSafe array. Must be used with a 20 W (or higher) wall adapter.

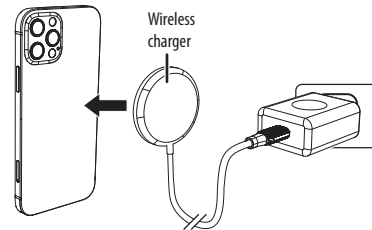
### Using your charging pad

- 1 Plug the USB-C end into a 20 W or higher power adapter (not included). Plug the adapter into a power outlet.



- 2 Place your Qi-enabled device on the center of your wireless charger with the screen facing out. Your device starts charging.

**Note:** The iPhone 12 series and 13 series will directly attach to the wireless charger.



### Troubleshooting

#### Device is not charging or charges slowly.

- Make sure that your 20 W or higher power adapter (not included) is connect to a working power outlet.
- Make sure that your device is positioned in the center of your charging pad.
- Make sure that there are no other objects on the charging pad.
- Try removing your device's case.
- Make sure that your device is Qi-enabled.
- Make sure that the AC wall adapter you are using is 20 W or higher.
- Using the phone while it is charging will make it charge more slowly.
- Your device may charge more slowly with the charging pad than a charging cable. This is normal.

#### My device gets warm while charging

- It is normal for devices to get warm while charging.

- Keep wireless charging pad away from any liquid or moisture.
- The maximum ambient temperature during use of this product must not exceed 104° F (40° C).
- Do not place this device in fire or other excessively hot environments.
- This product is intended for home office use.
- For indoor use only.
- Consult local staff before using the product near medical or industrial equipment or on board an aircraft.
- Prevent cables from being pinched or damaged.
- A damaged cable or device may malfunction and/or overheat. (Fire hazard).
- Unplug the product if not used for an extended period of time.

## WARNING:

- People with pacemakers should keep away from the magnets. The magnets can negatively affect the function of the pacemaker.
- Do not place any bank or similar cards with magnetic strips or magnetically sensitive objects on the product. The data on the cards could be damaged or completely deleted.
