





## USING THE CHARGE STATION

1. Place the charging station on a flat and stable surface.
2. Separate the two magnetic USB-C adapters from the magnetic charging port of the charge station.




3. Attach magnetic USB-C adapters into the USB-C charging port of your PlayStation VR2 Sense controller. The left and right charging adapters are interchangeable.




**Note:** The magnetic USB-C Adapter is small and easy to lose. We recommend that you keep the magnetic USB-C adapter plugged into the controller.

4. With the magnetic USB-C adapters attached, place your Sense controllers into the charging station and make sure that the magnetic USB-C adapters adhere to the magnetic output connector.



5. Plug the USB power cable into a PS5 console or compatible USB charging adapter. The LED turns amber while charging, then turns blue when finished.

## ONE-YEAR LIMITED WARRANTY

### **Definitions:**

The Distributor\* of Insignia branded products warrants to you, the original purchaser of this new Insignia-branded product ("Product"), that the Product shall be free of defects in the original manufacturer of the material or workmanship for a period of one (1) year from the date of your purchase of the Product ("Warranty Period").

For this warranty to apply, your Product must be purchased in the United States or Canada from a Best Buy branded retail store or online at [www.bestbuy.com](http://www.bestbuy.com) or [www.bestbuy.ca](http://www.bestbuy.ca) and is packaged with this warranty statement.

### **How long does the coverage last?**

The Warranty Period lasts for 1 year (365 days) from the date you purchased the Product. Your purchase date is printed on the receipt you received with the Product.

### **What does this warranty cover?**

During the Warranty Period, if the original manufacture of the material or workmanship of the Product is determined to be defective by an authorized Insignia repair center or store personnel, Insignia will (at its sole option): (1) repair the Product with new or rebuilt parts; or (2) replace the Product at no charge with new or rebuilt comparable products or parts. Products and parts replaced under this warranty become the property of Insignia and are not returned to you. If service of Products or parts are required after the Warranty Period expires, you must pay all labor and parts charges. This warranty lasts as long as you own your Insignia Product during the Warranty Period. Warranty coverage terminates if you sell or otherwise transfer the Product.

### **How to obtain warranty service?**

If you purchased the Product at a Best Buy retail store location or from a Best Buy online website ([www.bestbuy.com](http://www.bestbuy.com) or [www.bestbuy.ca](http://www.bestbuy.ca)), please take your original receipt and the Product to any Best Buy store.
