

S4 User Manual

1.0 Introduction



Note:

*For the first use, please charge with cable to activate/turn on the watch.

*You can set the screen-on time(5-20s): Setting-Screen timeout.

1. Open the package and check the product.
2. Package contents: (1) TOZO S4 Smart watch (with built-in lithium battery);(2) User guide; (3) Charging cable.
3. Connect the contact points of the magnetic charging cable to the contact points of the watch to charge and activate the device, and to turn it on.
4. Search for "TOZO Health" in your mobile app store and download, or scan the QR code(on the Right) to install the app.



5. Open the app, tap the "More" icon in the upper right corner, select "Add Device", select the device category, and select the device you wish to link in the corresponding search list. You may also link the device directly by scanning the device's QR code using the scan function.

2.0 Health

2.1 App


1. Start "TOZO Health", enable the Bluetooth feature, and grant the GPS positioning permission.
2. Light up the bracelet screen and bring it close to your phone.
3. Click "Bind Device" on the App, and select the bracelet model in the search results to bind.
4. Confirm the binding request on the bracelet.
5. Fill in your information and set your step goal on the App to complete the binding.

2.2 Watch

1. Record your data, measure your heart rate, Blood oxygen monitor(SpO2) and stress test. Monitor your heart rate and sleep night.
2. Start an exercise.
3. Start the sports App on the bracelet, click the Icon of sports type and the the goal to exercise.

3.0 Basic Operations

1. Wear it correctly: make sure that the bottom sensor is properly attached to the skin, and the strap shall be one finger away from the wrist.
2. Touch operation: TOZO S4 supports full-screen touch operations.
3. Button: TOZO S4 has a physical button.
Short press: Return or close a notification.



4.0 Function Description

4.1 Dial

You can switch between different dials in the "Dial Settings". And you can download and install more dials in the "Dial Market".

4.2 Sports

There are 100 sports types, you can choose 10 commonly used ones to display on the watch, and the rest of the sports types can be exchanged through the APP:

Outdoor walk\Indoor walk\Outdoor run\Indoor run\Outdoor cycle\Indoor cycle\Outdoor hiking\Yoga\Gym\Stepper. You can choose to show or hide any sports mode in "TOZO Health".

The Sports Summary of TOZO S4 contains a variety of sports data, and the details can be viewed in the "TOZO Health".

The movement distance of this product is calculated by the step count value. Please fill in the information parameters accurately when start setting (height/weight/age).

When doing outdoor sports without continuous arm swing, such as riding, please turn on the exercise interface in the app, which will record your exercise data more accurately.




4.3 Apps

Swipe up or down to select an icon. The icons include: Message, Health Data, Workout, Heart Rate, Stress, Blood oxygen monitor(SpO2), Sleep, Relax, Music, Time, and Settings.




4.3.1 Call Function

1. Compatible for voice call with features such as dial/ answer/ mute and reject calls as long as the smart phone is nearby and connected to the watch.
2. It takes in 10 contacts from your phone via "TOZO Health" for speed dial.
3. You may dial a number or call up a contact from the call log on the watch.




4.3.2 Health Data



It supports viewing the daily accomplishment of the following info: Steps, Calories, Distance and Activity.

4.3.3 Heart Rate



1. It supports measuring your heart rate any time or viewing the daily monitoring data. Also, you can set the measurement frequency in the App settings;


2. After you start the heart rate measurement App, you should keep your arms and wrists still during the measurement.

4.3.4 Stress



After you start the stress measurement App, you should keep your arms and wrists still during the measurement.


4.3.5 Blood Oxygen Monitor(SpO2)



1. The setting mode of blood oxygen function is active test, and the measurement data will be displayed on the watch and app only after turn on measurement manually.


2. After you start the blood oxygen monitor(SpO2) measurement App, you should keep your arms and wrists still during the measurement.

4.3.6 Sleep



You can view the most recent sleep record and sleep status at each stage.

4.3.7 Relax





1. Enter the Relax App and choose the duration;
2. Click to start, then follow the vibration frequency and animation instructions to adjust your breathing and it will help you relax.

4.3.8 Stopwatch




stopwatch and a timer are provided.

4.3.9 Alarm




The watch can be set to add, delete, turn on/off the alarm; you can also set the alarm to the watch through the APP; you can also set the label you need in the alarm to identify the alarm.

4.3.10 Timer





You can set a timer with a preset duration on the watch, and the timer will remind you when the timer expires; you can customize the timer time.

4.3.11 Weather





1. Supports three-day weather viewing, you can view today's "current weather, highest and lowest weather values" and the "highest and lowest weather values" for the next two days.
2. To ensure the accuracy of weather data, please try to keep the watch connected to the "TOZO Health" app.

4.3.12 Music




1. Introduction to music control function: the device can control the music application on the mobile phone, switch songs and adjust the volume of songs played.
2. You need to open the music playback app on your mobile phone to set it.
3. To use this function, you need to enable Device>More Setting>Music control in "TOZO Health" first. If it is not on, the device cannot control music.
4. During the use of this function, please keep the device connected to "TOZO Health".
5. The watch device can +/- volume in the music interface, and the mobile phone music volume can be adjusted synchronously when connected.

4.3.13 Exercise Record





You can view your recent exercise records on the watch, including detailed data about your exercise; you can also view the exercise records on the APP.

4.3.14 Fine Phone




1. When the watch is connected to the APP, you can make your phone ring.
2. Click the icon to end the ringing.



4.3.15 Settings



1. You can set the length of screen-on time from 5s-20s: Settings--Brightness--Screen-on time.
2. You can set your wrist-lifting screen, and do not disturb switch on the watch. This function can be displayed\hide in the APP settings.
3. You can switch the locally stored watch face on the watch.
4. You can set the brightness of the watch, and set the switch to reduce the brightness at night.
5. You can control the shutdown, restart, and factory settings of the watch on the watch.(after restoring the factory settings, all data in the watch will be cleared and the binding relationship with the phone will be released).

4.3.16 Message





The watch supports multiple reminder modes, including message reminder, incoming call reminder, low power reminder, health reminder, alarm reminder, etc.

4.3.17 Updates and Feedback

1. Please pay attention to the new version update information of watch and app (where to find the update information of APP : (My>check for updates; Watch update information will be reminded in pop-up mode).
2. For any assistance, please feedback to customers service team in the "My>problems and suggestions" column on the app, and we will solve them for you at the first time.


