


Minimum clearances from adjacent combustible construction

- Cooking surface and below, 36" (91.4 cm) and below
 - Sides—0"
 - Rear—0" with backguard or highshelf; 0" with island trim and noncombustible rear wall; 6" (15.2 cm) with island trim and combustible rear wall.
- Above cooking surface, above 36" (91.4 cm)
 - Sides—6" (15.2 cm)
 - Within 6" (15.2 cm) side clearance, wall cabinets no deeper than 13" (33.0 cm) must be minimum 18" (45.7 cm) above cooking surface.
 - Wall cabinets directly above product must be minimum 42" (106.7 cm) for open top burners above cooking surface.



- This range may be installed directly adjacent to existing 36" (91.4 cm) high base cabinets. **IMPORTANT:** The side trim MUST be 3/8" (.95 cm) above the adjacent base cabinet countertop. This can be accomplished by raising the unit using the adjustment spindles on the legs.
- The range CANNOT be installed directly adjacent to sidewalls, tall cabinets, tall appliances, or other side vertical surfaces above 36" (91.4 cm) high. There must be a minimum of 6" (15.2 cm) side clearance from the range to such combustible surfaces above the 36" (91.4 cm) counter height.
- Within the 6" (15.2 cm) side clearance to combustible vertical surfaces above 36" (91.4 cm), the maximum wall cabinet depth must be 13" (33.0 cm) and wall cabinets within this 6" (15.2 cm) side clearance must be 18" (45.7 cm) above the 36" (91.4 cm) high countertop.
- Wall cabinets above the range must be a minimum of 42" (106.7 cm) above the range cooking surface for the full width of the range. This minimum height requirement does not apply if a range hood is installed over the cooking surface.

Note: If a range hood is installed, wall cabinets above the rangetop have a different minimum clearance height

Note: Minimum clearance for back wall is 0" with backguard or high-shelf.



Clearance Dimensions - (Wood/Composite Overlay)

The bottom of a standard hood should be 30" (76.2 cm) min. to 36" (91.4 cm) max. above the countertop. This would typically result in the bottom of the hood being 66" (167.6 cm) to 72" (182.9 cm) above the floor. Refer to the range hood installation instructions for additional information. These dimensions provide for safe and efficient operation of the hood.

Electrical Requirements

Electrical Requirements

Electrical installation should be performed by a licensed electrician. Wire size and electrical requirements, per NEC and Local Codes, should be verified prior to installing the product. This product is manufactured so that either a 3 wire or 4 wire option, for connection, can be used. The product comes standard setup for a 3-wire connection with the Neutral connected to the cabinet. Refer to Page 12-15 for instructions on each of the options



General Information

READ AND FOLLOW ALL WARNING AND CAUTION INFORMATION WHEN INSTALLING THIS APPLIANCE

- All openings in the wall behind the appliance and in the floor under the appliance must be sealed.
- DO NOT obstruct the flow of combustion and ventilation air.

⚠ CAUTION

Avoid any damage to oven vents. The vents need to be unobstructed and open to provide proper airflow for optimal oven performance

⚠ CAUTION

The cooling fan should be operating when the unit is in operation. If you notice the cooling fan is not operating or you observe unusual or excessive noise coming from the cooling fan, contact a Viking Authorized Service Center before continuing operation. Failure to do so can result in damage to the oven or surrounding cabinets.

Moving, Handling, and Unpacking

Remove and discard all packing materials, including cardboard and tape on the outside and inside of the range.


DO NOT discard the anti-tip metal brackets (2) supplied with the range. These are the anti-tip devices and one must be installed with the unit.

Type 1 is a wall mount device which can be used for all installation applications.

Type 2 is a floor mount device which can be used for all applications other than when the range is installed on a concrete sub-floor.

Important – The range **MUST** be installed with one of the anti-tip devices. Refer to “Anti-tip Device Installation” section.

Some stainless steel parts may have a plastic protective wrap which must be peeled off. The interior should be washed thoroughly with hot, soapy water to remove film residues and any dust or debris before being used, then rinsed and wiped dry. Solutions stronger than soap and water are rarely needed.




Door Removal

CAUTION


To avoid risk of personal injury or product damages, DO NOT use the handle or oven door to lift the oven. Remove door before installation to ensure that it is not used to lift the unit. DO NOT lift or carry the door by the handle. Removing the door must be done by your dealer, or a qualified licensed plumber.



Open door completely. Fold latches back until locked in place. not secure for long transit.




Gently close until latches stop door




Lift door up and out.


Leg Installation




Legs are packed in styrofoam top pack. Note: Legs should be installed near to where appliance is to be used, as they are not secure for long transit.



Note: It is strongly recommended that a pallet or lift jack be used rather than tilting. Raise unit about a foot.
Unscrew temporary legs from couplings.



Screw legs into couplings on all four corners.



Lower range gently to keep any undue strain from legs and internal mounting hardware.


ELECTRICAL GROUNDING INSTRUCTIONS
To avoid risk of electrical shock, personal injury or death; verify your appliance has been properly grounded in accordance with local codes or in absence of codes, with the National Electrical Code (NEC). ANSI/NFPA-70 – latest edition. Grounding product to the frame of the unit may or may not be permitted through your local codes. If ground to the frame is not permitted then a 4-conductor powercord must be used.

Where local codes do not permit grounding through neutral, use a 4-wire power supply cord. The cord or conduit must be secured to the range with the strain relief bracket. The electrical connection is made at the terminal block, which is located behind the access door on the back of the range




To support different electrical connection options, the terminal block can be rotated 180 degrees.






Remove supply cord strain relief bracket and three supply cord mounting screws on terminal block.




Feed supply cord up through hole in bottom of range back.



Attach line #1(black) and line #2(red) leads to outside terminal. Attach neutral wire (white) to center terminal on the terminal block.







Electrical Connection (4-wire)


Where local codes do not permit grounding through neutral, use a 4-wire power supply cord. The cord or conduit must be secured to the range with the strain relief bracket. The electrical connection is made at the terminal block, which is located behind the access door on the back of the range






Remove supply cord strain relief bracket and three supply cord mounting screws on terminal block.




Remove grounding screw. Cut-off and discard ground strap.






Attach ground wire (green) with ground screw that was removed.

Wall Mount Anti-tip Installation




Measure from floor to bottom of the anti-tip opening located on the back of range.


This will be measurement (A).



Locate anti-tip bracket on rear wall with the top left corner at measurement (A) plus 1/2" (1.3 cm) from the floor and 3-5/8" (9.2 cm) from where the right side of range (facing range) is to be located.




Mark and drill holes where bracket will be located




Attach bracket with mounting hardware provided.

Floor Mount Anti-tip Installation



Dim A from Rear Wall Without Standoffs	3-5/8" (9.2 cm)
Dim A from Rear Wall With Standoffs	6-5/8" (16.8 cm)

Refer to chart for dimension A based on whether or not standoffs are used with the rear trim device. Mark and drill 1/8" (.32 cm) holes where bracket will be located.




Mount anti-tip bracket hook to floor using screws provided.


Remove two screws from back of range

Attach bracket to back of range using two screws.


Final Installation



Connect electrical in shaded area. See the "Electrical Requirements" section for more information.




Slide range into place. Whether using the wall or floor anti-tip, be sure anti-tip bracket slides into the anti-tip opening.




Check that unit is level side to side and front to back. The side trim must be $3/8"$ (0.95 cm) above countertop. If unit is not level repeat Steps 5-7 of "Leveling/Adjustments/Alignment" section.


Door Replacement



Carefully realign door on hinges.
Slide in and down



Open door completely.
Fold latches forward until locked in place.

Final Installation

All stainless steel body parts should be wiped with hot, soapy water and with a liquid cleaner designed for this material. If buildup occurs, DO NOT use steel wool, abrasive cloths, cleansers, or powders! If it is necessary to scrape stainless steel to remove encrusted materials, soak with hot, wet cloths to loosen the material, then use a wool or nylon scraper. DO NOT use a metal knife, spatula, or any other material tool to scrape stainless steel! Scratches are almost impossible to remove.

⚠ NOTICE

When conducting performance test, DO NOT run self-clean cycle for more than 10 minutes with oven racks inside oven. This could cause them to discolor due to the high temperature required for self-cleaning.


Service & Registration
