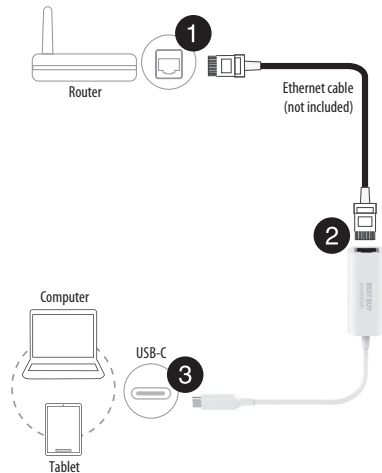

Connecting your adapter

- 1 Connect an Ethernet cable (not included) to your router.
- 2 Connect the other end of the cable to the adapter.
- 3 Connect the adapter to a USB-C port on your device.

- Make sure that the cables are not damaged.
- Try connecting to another USB-C port.
