

HOW TO QUALIFY:

PURCHASE Sub-Zero, Wolf, Cove between NOW and 11/30/2032 and MUST TAKE DELIVERY by 12/31/2032

All major, serialized Sub-Zero, Wolf, Cove units purchased will qualify for the rebate. Sales accessories, floor models, open-box units, tax, delivery, installation, builder, wholesale, and multi-family purchases do not qualify. Limit: one rebate per household.
