




- Keep batteries out of the reach of children.
- Do not heat, open, puncture, mutilate, or dispose of batteries in fire.
- If a battery leaks, remove the battery, taking care to keep the leaked fluid from touching your skin or clothes. If fluid from the battery comes into contact with skin or clothes, flush skin with water or remove the clothing immediately. Before inserting a new battery, thoroughly clean the controller with a damp paper towel.
- Do not allow metal objects to touch the battery terminals, because they can become hot and cause burns. For example, do not carry the battery in a pocket with keys or coins.
- Remove the battery when the controller will not be used for an extended period of time
- CAUTION: Do not open, crush, heat. Maxmun operation Temperature 45°C.

INSTALLING THE BATTERY PACKS

1. Press the Eject button to release original battery cover and slide out.



2. Install the rechargeable battery pack making sure you have it aligned with the correct polarity. Slide the custom battery door onto the controller.



* Grips need to be removed before using controller charging dock.

META QUEST 3 SETUP


1. Plug the AC adapter into a power outlet, then connect the AC power adapter to the jack on the bottom of the charging dock.

2. Set your touch plus controllers on the charging dock on their sides with the grip button facing upward.

Set your headset on the charging dock with the front of the headset facing toward you.


4. The power LED indicators will turn on.

5. When charging Quest 3 with an elite strap with battery. Plug the elite strap cable into the headset. Ensure the arms are horizontal before docking the headset. Leave strap battery connected to headset to charge simultaneously.



META QUEST 3S SETUP

1. Extract the built-in USB-C charging cable from the bottom of the charging dock and connect it to the charging port on the MQ3S.

TROUBLESHOOTING

Charging dock doesn't charge

- Make sure that the Headset charging plug adheres to the Metal Pins Charging Contact.
- $\bullet \ \ \text{Make sure that each rechargeable battery is correctly installed in the Touch plus controller.}$
- $\bullet \ \ \text{Make sure that the custom battery door is correctly installed on the Touch plus controller.}$
- Made sure that you have connected the AC power adapter to the charging dock and a working power outlet.

Battery life seems short

- Make sure that the battery is fully charged before disconnecting from the charging dock.
- Leaving your fully charged controller on the charging dock for extended periods of time will limit your battery's lifespan and performance.
