If you have submitted a claim under the warranty period, and you have returned the product to us according to our specifications, we will repair or replace the product at no cost to you.

If the product issue is not covered under the lodge warranty, or the warranty has expired, we will inform you of your options for service and/or replacement and the fee associated with that.

The warranty period is not extended if we repair or replace your product.

Limitations - The foregoing warranty does not extend to problems in the Product that result from:

- use of the Product in a way for which it was not designed.
- use of the Product with other products, hardware or products not supplied by, and inconsistent with the documentation provided by lodge.
- failure to update the product with firmware fixes made available by lodge.

If the product issue is not covered under the lodge warranty, or the warranty has expired, we will inform you of your options for service and/or replacement and the fee associated with that.
