HOW TO QUALIFY

1 PRE-REGISTER prior to purchase. Submit to Jessee.Tipton@subzero.com.

- Copy of your insurance claim with the address of the home clearly listed.
- Dealer itemized quote of Sub-Zero, Wolf, Cove, and/or Asko package matching the address in the insurance claim.

2 PURCHASE Sub-Zero, Wolf, Cove and/or Asko products between May 1, 2018 – April 30, 2020.

- Qualifying package consists of 1.) any full-size Sub-Zero refrigerator 2.) any size Wolf range OR any size Wolf wall oven with any size Wolf rangetop or cooktop* 3.) any Cove or Asko dishwasher model
- All major, serialized Sub-Zero, Wolf, Cove, and/or Asko units purchased will qualify for the rebate. Sales accessories, floor models, open-boxed units, tax, delivery, installation, builder and wholesale purchases do not qualify.

3 RECEIVE your 10% rebate in the form of a prepaid card.

Two-15" Module Cooktops qualify as a cooktop) 3.) any Cove or Asko dishwasher model. All major, serialized Sub-Zero, Wolf, Cove, and Asko products qualify for 10% rebate. Sales accessories, floor models, builder quotes, open-boxed units, tax, delivery and installation do not qualify. Qualifying products must be purchased between May 1, 2018 – April 30, 2020 and delivered by November 30, 2020 to be eligible to receive a 10% rebate. Please allow 4-6 weeks to receive your Visa Prepaid card once your claim has been approved. Builder and wholesale purchases do not qualify. Cards are non-transferable and cannot be redeemed for the cash value. Please retain a copy of the complete form and invoice for your records, claim submission will not be returned. Limit one rebate per sale and per customer. Can be combined with other promotions in place at the time of order and delivery. Reward paid via a Visa Prepaid card in US dollars.
