



# WARRANTY

---

For fifteen years from the date of purchase, when this product is installed, operated and maintained according to the Manufacturers valid installation instructions attached to or furnished with the product, Swisstrax® will replace the defective product or parts if the part fails as a result of manufacturing defective materials or workmanship. Swisstrax® Limited Warranty shall apply only if the warranty claim, box labels and proof of purchase is received by Swisstrax® within the limited warranty period.

## **Swisstrax® Limited Warranty shall not apply to:**

- ⊕ Service calls (site visits) to correct the installation of any Swisstrax® products or to instruct you how to use or install our products.
- ⊕ Damage resulting from improper handling or shipping of products, or products damaged by accident, misuse, abuse, fire, flood, improper installation, acts of God, neglect, corrosion, modification or mishandling.
- ⊕ Shipping or freight fees to deliver replacement products or to return defective products.
- ⊕ Repairs or replacement when your product is used in other than normal, single-family household use, such as a commercial environment, or handled in any way inconsistent with the installation instructions included with the product.
- ⊕ Cosmetic damage, including stains or discoloration, which does not affect the structural or functional capability of the product.
- ⊕ Replacement product for Swisstrax® products operated outside the United States or Canada.
- ⊕ In Canada, travel or transportation expenses for customers who reside in remote areas.
- ⊕ Any labor costs during the limited warranty period.
- ⊕ Surfaces damaged due to chemical interaction.
- ⊕ Damage resulting from failure to install the tile floor covering with the tread plate surface facing upward.
- ⊕ Damage caused by mold, mildew, fungus or bacteria.
- ⊕ Damage from improper use including without limitation, burns, cuts, scratches, scuffs, punctures and indentations.
- ⊕ Damage caused by permanently adhering the tile floor covering to the surface of the existing garage floor.
- ⊕ Damage from extended direct exposure to sunlight.
- ⊕ Damage from excessive moisture, alkaline and hydrostatic pressure damage from sub floor.
- ⊕ Damage caused from improper installation.
- ⊕ Swisstrax flooring has to be checked for existing defects before and during its installation. Flooring which has been installed in spite of visible defects, is exempt from the warranty
