Using the cooling stand


You can use the cooling stand with or without running the fan.




To set up the cooling stand:Open the cover on the bottom of the cooling stand.



2 Pull the USB cable from inside the compartment, then clip the cable into the cable guide.



3 Close the cover.




4 Plug the USB cable into a USB port on your laptop. The cooling fan turns on.






5 To adjust the height of the cooling fan, pull out the support on the bottom of the stand.



6 Make sure that the support is fully extended for correct alignment.



7 Place your laptop on the center of the cooling fan.

One-Year Limited Warranty

Rocketfish Products ("Rocketfish") warrants to you, the original purchaser of this new **RF-LAPCOL** ("Product"), that the Product shall be free of defects in the original manufacture of the material or workmanship for one (1) year from the purchase of the Product ("Warranty Period"). This Product must be purchased from an authorized dealer of Rocketfish brand products and packaged with this warranty statement. This warranty does not cover refurbished Product. If you notify Rocketfish during the Warranty Period of a defect covered by this warranty that requires service, terms of this warranty apply.

How long does the coverage last?

The Warranty Period lasts for one year (365 days), beginning on the date you purchased the Product. The purchase date is printed on the receipt you received with the product.

What does this warranty cover?

During the Warranty Period, if the original manufacture of the material or workmanship of the Product is determined to be defective by an authorized Rocketfish repair center or store personnel, Rocketfish will (at its sole option): (1) repair the Product with new or rebuilt parts; or (2) replace the Product at no charge with new or rebuilt comparable products or parts. Products and parts replaced under this warranty become the property of Rocketfish and are not returned to you. If service of Products and parts are required after the Warranty Period expires, you must pay all labor and parts charges. This warranty lasts as long as you own your Rocketfish Product during the Warranty Period. Warranty coverage terminates if you sell or otherwise transfer the Product.

How to obtain warranty service?

If you purchased the Product at a retail store location, take your original receipt and the Product to the store you purchased it from. Make sure that you place the Product in its original packaging or packaging that provides the same amount of protection as the original packaging. If you purchased the Product from an online web site, mail your original receipt and the Product to the address listed
