







Icon	Function	Description
	Volume down	Press to decrease the volume. Hold down to decrease the volume quickly.
	Mute	Press to turn the sound off.
	Volume up	Press to increase the volume. Hold down to increase the volume quickly.
	Previous	Press to select the previous music or video track.
	Play/Pause	Press to play or pause music or video.
	Next	Press to select the next music or video track.
	Stop	Press to stop playing music or video.
	Sleep	Press to put your computer into sleep mode.
	Home	Press to open a home page in your browser.
	Refresh	Press to reload an open web page.


Setting up your mouse

- Plug your mouse into an available USB port on your computer. The computer automatically detects the mouse and you can immediately begin using it.



Setting up your keyboard

- Plug the keyboard into an available USB port on your computer. You can begin using your keyboard immediately after Windows automatically finds and installs the appropriate driver.



Cleaning your mouse and keyboard

- Wipe the mouse and keyboard with a damp, lint-free cloth.

Troubleshooting

My mouse and/or keyboard is not working.

- Make sure that your computer meets the system requirements.
- Make sure that your mouse and keyboard USB cables are securely attached to the USB ports on your computer.
- Only use the mouse on a clean, flat, non-slippery surface to ensure smooth and accurate cursor action.
- Try connecting your mouse and keyboard into different USB ports on your computer.
