



LIMITED WARRANTY

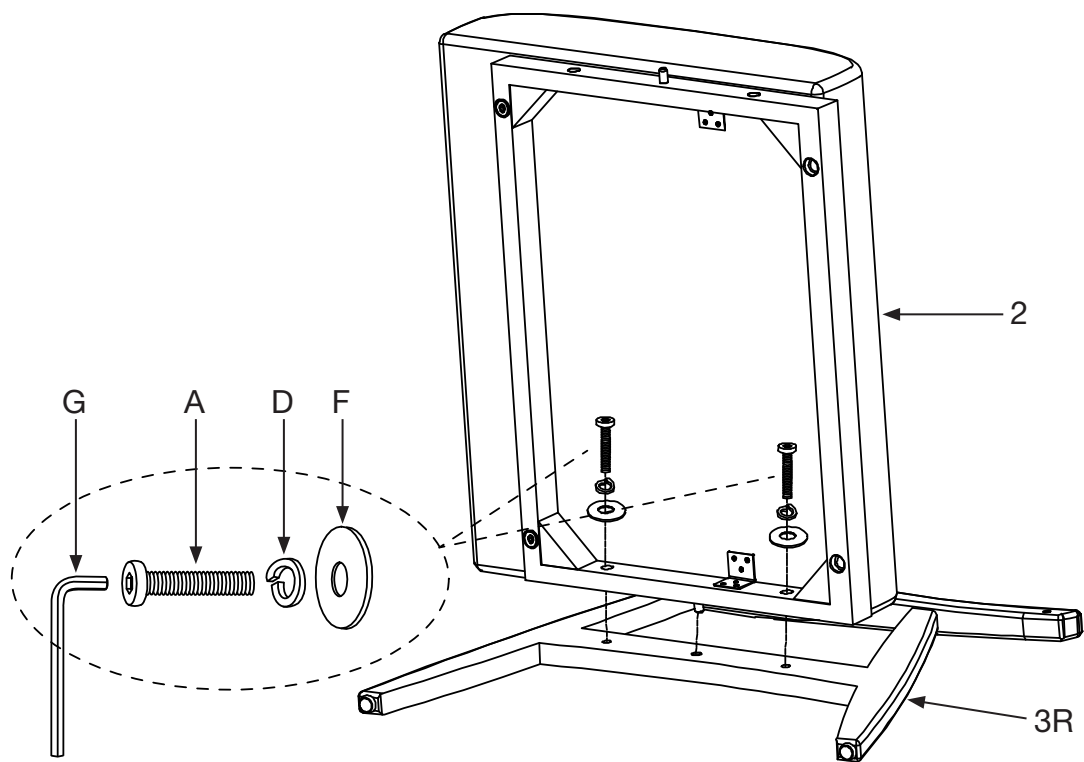
Assembly Instructions - Important:

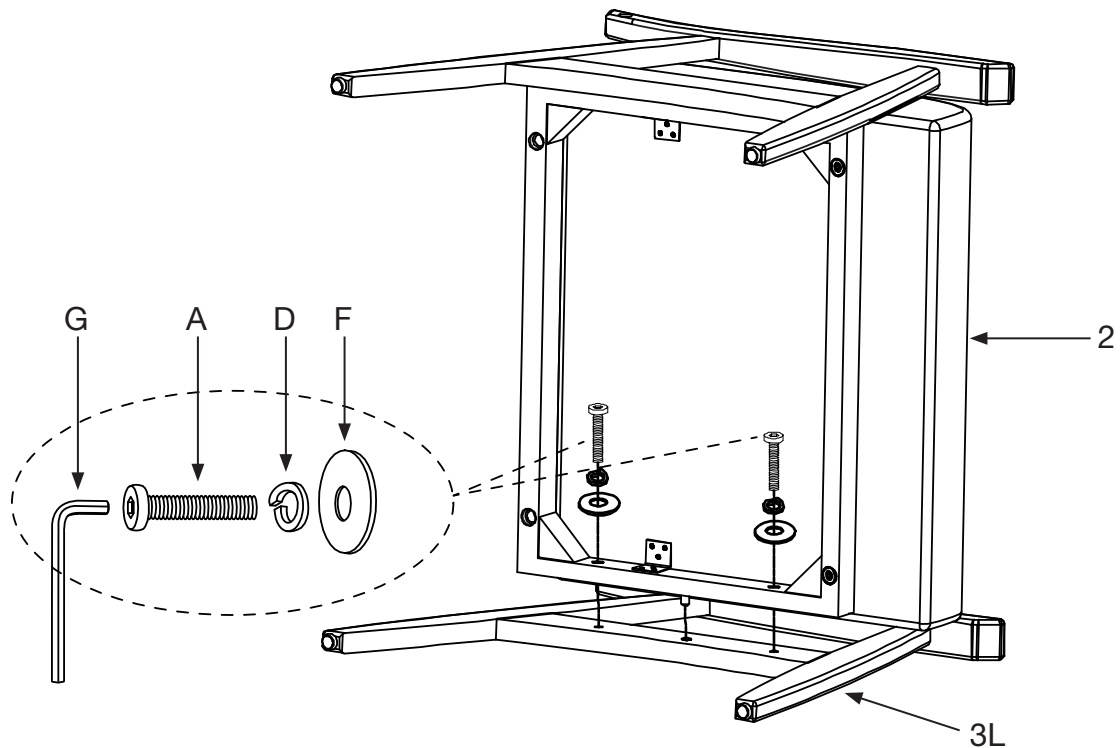

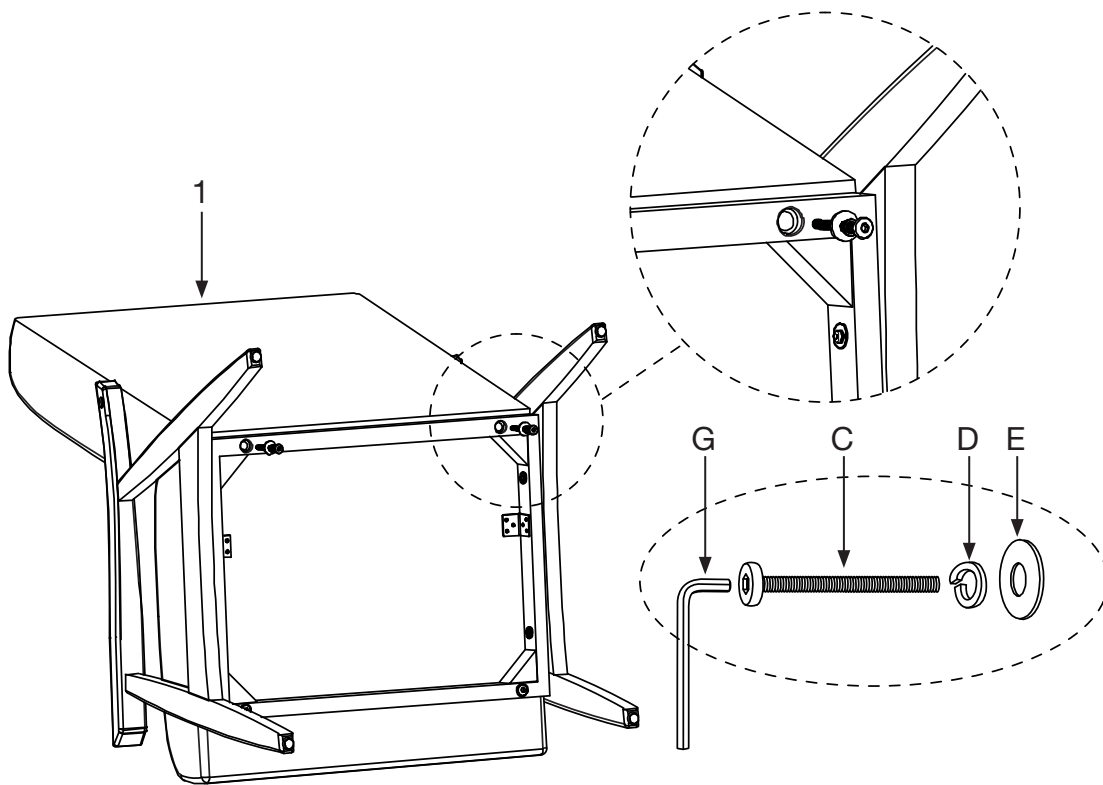

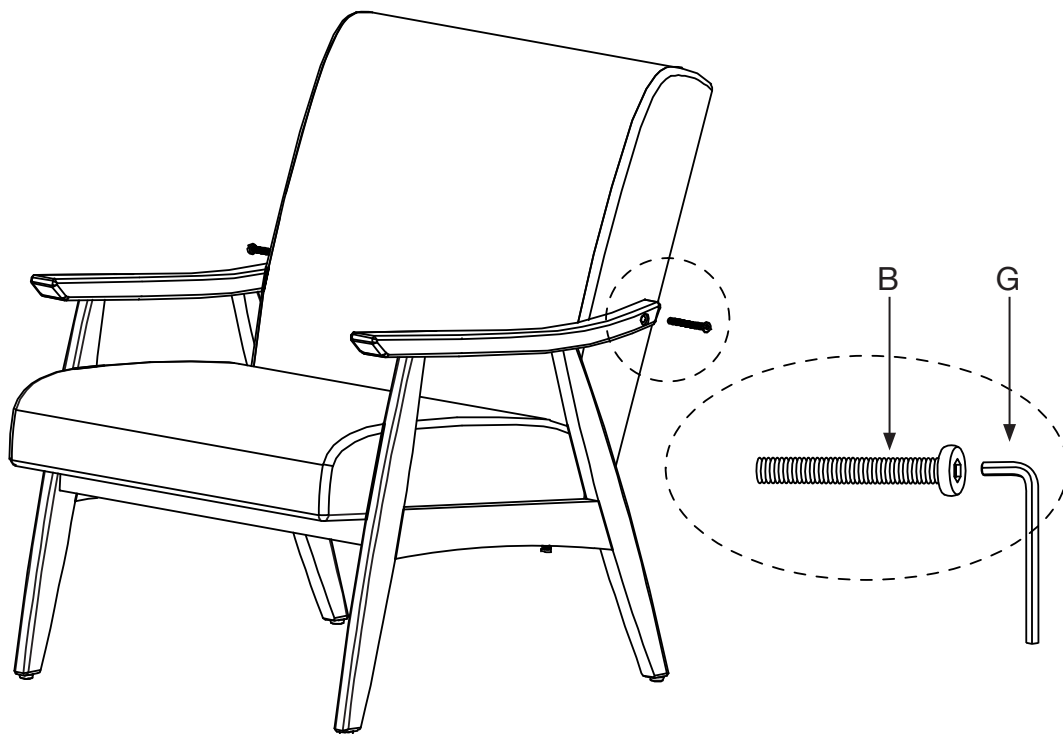
